<u>Elective Subjects:</u> Accountancy, Biology, Business Studies, Chemistry, Computer Science, Economics, Informatics Practices, Mathematics, Physical Education, Physics

The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary classes:

- 1. "The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Senior School Certificate Examination and changes made therein from time to time."
- The school will implement Continuous and Comprehensive Evaluation (CCE) as per the schemes of the Board upto Classes X.
- 3. As per the newly implemented CCE scheme vide Circular No. 39/20-09-2009 dated 20.09.2009, the students of class X will appear in the Summative Assessment-II (SA-II) conducted at the school level only. However, those students of class X, who opt to move out of CBSE system in Class XI to any other Board, will exercise the option to appear in the SA-II conducted at the Board level. Both the students will get the same certificate issued by the Board at the end of class X.
- 4. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State Govt./UT.
- The school will provide additional suitable facilities for classes XI and XII, as per requirements laid down in the rules.
 - It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.

- It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.

16. Special conditions to be complied within three months:-

- An affidavit duly sworn in before a First Class Magistrate by the President or Secretary of the society/Trust running the school to the effect that the society is of non-proprietary Character in nature is required to be submitted.
- CCE advocacy workshop for principal and teachers is required to be arranged for effective implementation of CCE.
- Enrolment is very high in some sections whereas the school is required to restrict the optimum number of 40 students in each section.
- It is mandatory for every affiliated school to become a member in the local sahodaya of CBSE schools.
- Every school should organize at least one week training programme for teachers every year in association with any teachers training institute recognized by the State or Central Government or by any agency identified by the Board.
- Every institute will provide adequate facilities for potable drinking water and clean healthy and hygienic toilets with washing facilities for boys and girls separately in proportion to the number of students.
